For the year, a supplemental budget of P16,800,000.00 was released to cover additional budget for the on-going programs and projects of the Authority, particularly for the payment of real property taxes; titling/surveying of proclaimed lots; and, feasibilities sstudies for the existing projects/properties to improve its revenue generation.
