SOUTHERN PHILIPPINES DEVELOPMENT AUTHORITY REPORT OF ACCOMPLISHMENT/ACTIVITIES FY 2022

OPERATIONAL HIGHLIGHTS

SPDA VITALI FISHPOND PROJECT Vitali, Zamboanga City Region IX



For CY 2022, the project is targeted to operate nine fishponds (Pond#101-109) covering an area of 17.08 hectares. In preparation for that, during the First Quarter, the cleaning of nine ponds and the purchase of various production supplies and materials were started. A total of 36,000 fingerlings were purchased, and the first seeding was conducted on March 07, 2022.

Pond# 101 was urgently harvested on June 04 due to a lack of oxygen; the salinity was mixed with water coming from rain and there was no more Algae (Lumut) to be eaten.

Ponds# 105-A, 105-B, 106, and 108 were harvested on June 07, Ponds# 102 and 104 was on June 10, and Ponds# 103 and 107 were harvested on June 16. It had produced a total of 4,442 kgs. of milkfish.

No prawn and crab production were conducted during the year due to no budget allocated for these activities.

SPDA KORONADAL BUSINESS CENTER Koronadal City SOCSKSARGEN



For CY2022, the operation of the project is still ongoing, and it generated a total gross revenue of ₱2,707,153.87 covering the period of January to December. The revenue was coming from Rent Income (Function Hall, Social Hall and Commercial Space) of ₱1,272,072.87 and Sales Income (Hotel and Canteen) of ₱1,435,081.00. A total Net Income with a cash value of ₱652,993.83 was obtained before Depreciation costs and a minimal Net Loss of ₱1,363,356.99 after the non-cash expenses were deducted.

The Authority is also waiting for the payment of more or less ₱800,000 from the Provincial Government Office, booked up as Accounts receivable, wherein 18 rooms of the Hotel were used as Quarantine facilities for COVID-positive patients in the recurring Pandemic situation.

As of December CY 2022, the SPDA Koronadal Business Center has a total liquid Cash In-Bank of **₱1,774,732.83**, enough to sustain the project's monthly expenses for Personal Services, MOOE and Production Cost.

SPDA Annual Report of Accomplishment FY-2022

SPDA POULTRY PROJECT Brgy. Labon, Sulop Davao del Sur



The Broiler Production Project was divided into Four (4) Components: 1.) Civil Works; 2.) Water Supply System; 3.) Supply, Installation and Commissioning of Equipment (Electro-Mechanical) with Complete Controls and Accessories and; 4.) Supply, Installation and Commissioning of Two (2) Units 100KVA Diesel Genset with Complete Controls and Accessories.

The Water Supply System and Civil Works components were both commenced last September 2021 and completed last November 2021 and October 2022 respectively.

The supply of two (2) units 100KVA Diesel Generating Set were already delivered on site and tested on December 15, 2022. The commissioning of this component will be done only when the poultry buildings are with complete set up of equipment and electrical loads.

For the Electro-Mechanical component, the Contractor placed the order for the livestockkeeping equipment last December 2022. The said equipment came from United States (VALCO Brand) and will take about 2-3 months to completely deliver on site.

- ✤ Also, in the afternoon of June 24, 2022, the Pre-Bid Conference of the Procurement for the Supply, Installation and Commissioning of Two (2) units of 100KVA **Diesel Generating Set with Complete Controls & Accessories** of SPDA Poultry Project was and attended conducted by prospective bidders thru online via Zoom Meeting Platform and at the SPDA Conference Room, Main Office, Davao City.



SPDA VETERANS AVENUE PROPERTY PROPOSED DEVELOPMENT Veterans Avenue, Zamboanga City



The Construction of the Two (2) Storey with Roof deck SPDA Veterans Office Building was commenced in the **First Quarter of CY 2022**. It started with the demolition and clearing of the project site old structures and other unnecessary objects. Excavation of protection/sheet piles along the properties affected during foundation excavations, building foundations and pedestals, and so with the retaining walls of the ground floor level were also completed.

For the **Second Quarter up to the Last Quarter of CY 2022**, the work accomplishments of the said project were continuously progressing. All civil work components were already completed, while plumbing, electrical and Architectural design were still ongoing.



Last October 4, 2022, Amanah Islamic Bank Chairman & Chief Executive Officer Alex P. Bangcola met with top executives SPDA led by Deputy Administrator Munap H. Pacio with Operations Manager Cris B. Dagala and Corporate Affairs Department Manager Virginia L. Uy at SPDA Main Office in Davao City to thresh out business opportunities in Mindanao specially on the assets and ongoing projects of the Authority to include the plan of Amanah Islamic Investment Bank to lease the office space of the on-going SPDA Veterans Zamboanga City property Business Center. SPDA WAO AND AMAI MANABILANG LANAO DEL SUR PROPERTY Proposed for Development into an Agro-industrial Area Lanao Del Sur



For the **CY-2022**, the ASPAC Precision Ag had already mobilized their equipment, established their base of operations, and conducted route surveys for the proposed roads to be improved and/or developed in the area.

The Authority also signed a **Memorandum of Agreement (MOA)** on **March 14, 2022**, with the **Tokushima Auction Market (TAM)** for Collaboration and Cooperation in the development of an Agricultural Concession project that will be implemented in the SPDA-proclaimed area in Wao-Amai Manabilang, Lanao del Sur. In relation to that, the Budget Plan for the establishment of proposed Project Management Office has already been completed.

On **June 02, 2022**, the **RNF Industries Corporation** presented a letter of intent to signify their interest in developing an Avocado Plantation in Amai Manabilang, Lanao Del Sur, and currently the Authority is in the stage of identifying the viable or target areas to be assigned to them.

Another prospective locator, **Kennemer Foods International Inc. (KFI)**, signed a Lease Agreement with SPDA on **June 29**, **2022**, held at the SPDA Conference Room, Main Office, Davao City, for the development of the Lakatan-Cacao Plantation Project. The block assignment of the slopes and final areas to be assigned to the KFI has been finalized but is subject to verification and validation on the ground as to the actual topography and existing use.



- Ceremonial Signing of the Lease Agreement was signed between the SPDA led by SPDA Administrator Salapuddin and the Lanao del Sur Corn Development Corporation and ASPAC Precision AG led by President and Chief Executive Officer Wilson T. De Vera last February 7, 2022 at the SPDA Conference Room, Main Office, Davao City for the development of the agricultural plantations.
- Last March 14, 2022, a Memorandum of Agreement (MOA) was signed and forged with the Tokushima Auction Market (TAM) for Collaboration and Cooperation in the development of an Agricultural Concession project which will be implemented in SPDA Wao-Amai Manabilang Property.
- Last June 02, 2022, another prospective locator, RNF Industries Corporation, submitted thru electronic mail a Letter of Intent to signify their interest to develop an Avocado Plantation in Amai Manabilang, Lanao Del Sur.
- The Lease Agreement between the SPDA and Kennemer Foods International Inc. was signed last June 29, 2022 for the development of Lakatan-Cacao Plantation Project held at the SPDA Conference Room, Main Office, Davao City. During the meeting, the final location and site of block assignment of slopes was identified but subject for verification and validation in the actual topography and existing use in the area.



Last November 13, 2022, SPDA Administrator Salapuddin met Asia Pacific Precision Agriculture Group (ASPAC AG) Vice President for Mindanao Edward 'Boy' dela Fuente and BGen. Jovencio F. Gonzales, Assistant Division Commander for Operations of the Armed Forces of the Philippines (AFP) based in Awang, Cotabato. The meeting at the Apo View Hotel was conducted to thrash out pressing current challenges at the SPDA's proclaimed properties in the Municipalities of Wao and Amai Manabilang (formerly Bumbaran), Lanao del Sur.



Last Nov. 18, 2022, SPDA Administrator Salapuddin with SPDA Executive Officials briefed and discussed with MNLF (Misuari Faction) Vice Chairman and BTA Deputy Speaker Abdulkarim T. Misuari and Chief of Staff Abdulbasir Pula and Party on certain security issues and avoid any untoward incident and to promote cooperation attributed to the MNLF NASCOM Unit that established an outpost inside the corporate farm of SPDA Property in Wao and Amai Manabilang Municipality, Lanao del Sur.



Last November 30, 2022, Presidential Adviser on Peace, Reconciliation, and Unity (OPAPRU) Sec. Carlito G. Galvez, Jr. visited Southern Philippines Development Authority (SPDA) Office for a briefing and dialogue with SPDA Officials led by SPDA Administrator Salapuddin at SPDA Compound, Davao City to discuss the development issues and security concerns at the SPDA Agro-Industrial Development Program in Amai-Manabilang and Wao, Lanao del Sur administered property.



A meeting and dialogue between SPDA and the MNLF (NASCOM) and other stakeholders last December 21, 2022 was facilitated by OPAPRU Sec. Carlito G. Galvez and hosted by the Commanding General of the 6th ID PA Major Gen. Roy M. Galido, AFP at the Kampilan Hall of the 6th ID PA Headquarters at Awang, Cotabato City on the issues and security concerns of the SPDA Agro-Industrial Development Program in Amai-Manabilang and Wao, Lanao del Sur. An agreement was reached and signed by all stakeholders including Sec. Carlito G. Galvez, Major Gen. Roy M. Galido, MP and Deputy Speaker Karim Tan Misuari, Ret. P/Col. Sultan Mastura Manabilang representing Manabilang Municipality, MP Randy Karon, Eduardo dela Fuente, Vice President of ASPAC Precision AG Corp. and MP Atty. Randolph "Bong" Parcasio, former Administrator of SPDA.

SPDA AND REGIONAL BANGSAMORO BOARD OF INVESTMENT-BARMM PARTNERSHIP



Business and investment prospects of Southern Philippines Development Authority (SPDA) are expected to leapfrog into a higher gear this year following the signing of a **Memorandum of Agreement (MOA)** with the **Regional Bangsamoro Board of Investments - Bangsamoro Autonomous Region in Muslim Mindanao (RBBOI-BARMM)** last January 26, 2022 at the SPDA Conference Room, Main Office, Davao City.

The MOA signing between the two government entities this year marks another milestone in the history of SPDA for cooperation and partnership in the promotion of business and investments in the autonomous region and in the entire Mindanao.

The RBOI-BARMM delegation was headed by its **Chairman Atty. Ishak V. Mastura** with members **MP Atty. Suharto M. Ambolodto**; **Board of Governor Datu Mohammad Omar Pasigan**. The MOA signals the deepening entry and participation of the autonomous region in the business projects and investments of the Authority in this part of the country.

SPDA AND TOKUSHIMA AUCTION MARKET PARTNERSHIP



In partnership and cooperation on the development of the **Mindanao Agriculture Development Concession**, a **Memorandum of Agreement (MOA)** was signed between **Southern Philippines Development Authority (SPDA)**, **Tokushima Auction Market (TAM)**, a local enterprise of Tokushima Prefecture of Japan, **Global Trade Venture Co. Ltd.** and an American Company **Asia Pacific Precision AG Group Company** last March 14, 2022 at the Pinnacle Hotel and Suites, Davao City marks another historical milestone for the Authority.

In addition, a **Memorandum of Understanding (MOU)** was also signed between SPDA and the **Japan Medicinal Association** with its aim to integrate Japanese medical technology to the local market. Among their projects is to build a hospital and wellness center and to introduce the Japanese traditional technology and medicine to the Filipino people.

In attendance to witness the formal signing ceremony was **H.E. Amin Javadi, Head of Economic and Political Section of the Embassy of the Islamic Republic of Iran**, as an active partner and investor in the agriculture sector and the manufacture and assembly of affordable farm tractors for farmers, in order to modernize and mechanize the agriculture industry and special invited guest **Deputy Parliament Speaker Hatimil E. Hassan** of the **Bangsamoro Transition Authority (BTA)**.

Aiming for Mindanao to have modernization access to Agricultural and Aqua-Farming Concession that will be functional and benefited the local farmers and market; to yield better quality of products that eventually led to food security, sustainability and economic development that cater the needs of every Filipinos in the country in years to come.



With the remarkable total foreign investments (FI) in the country approved in the fourth quarter of 2021 amid the pandemic, higher by three-fold compared with the same quarter of 2020, this year sees more promising business activities in this part of Southeast Asian region as Southern Philippines Development Authority (SPDA) recently forged business alliance with Japanese and American investors.

A **Memorandum of Agreement (MOA)** was also signed last April 6, 2022 at the Garden Orchid Hotel, Zamboanga City on collaboration and cooperation in the development of the **Mindanao Aquaculture Concession** among **Tokushima Auction Market (TAM)**, **SPDA**, and **Asia Pacific Precision AG Group Company (ASPAC AG)**. Food Security of Japan is the end goal of this undertaking.

Represented by its **President and Chief Executive Officer Yoshihisa Arai**, Tokushima has proposed to undertake the Mindanao aquaculture concession project in the sea water and land in Mindanao to grow and harvest varieties of fish including crabs, white shrimps, and tiger prawns in cages and inland fishponds.

It has engaged **ASPAC AG led by its President and Chief Executive Officer Wilson T. De Vera**, to manage and help secure the proposed project site, provide manpower, and oversee the day-to-day operations.

Headed by **Administrator and Chief Executive Officer Abdulghani 'Gerry' Ajul Salapuddin**, SPDA shall lease out to Tokushima the use of the lands and waters inside its area of jurisdiction as project sites of the aquaculture concession project and as staging area for its fish corral aquaculture projects and support components like cold storage, packing plants and transport for export of the products. Last Novermber 29, 2022, SPDA Administrator Salapuddin with SPDA MLO-OIC Manager Atty. Datu Reza C. Sinsuat had a consultation meeting with the top executives of **Philippine** Credit Guarantee headed by SVP Celso R. Guttierrez accompanied by VP Eduardo S. Angeles and Marketing Ofiicer IV Ms. Claudette V. **Cayabyab** on the processes and procedures on the utilization of the guarantee provision mandates of the Authority held at the PHILGUARANTEE Office, BDO Towers. Makati City.



SPDA Administrator Salapuddin had a dinner meeting with a prospect Saudi investor Mr. Najeeb Al-Swailem, President and CEO of Al-Aslas Trading Corp. and Mr. Wilson T. On 17 August 2022, a formal visit was made to the Office of the Chief Minister in BARMM, wherein a meeting was requested to discuss matters related to trade and investments. A formal request for a suitable schedule was duly submitted, emphasizing the Authority's eagerness to foster productive collaborations.

Subsequently, on 12 October 2022, the RSO received a termination notice for its office space, necessitating the surrendering of all equipment and fixtures to the SKBC. The RSO swiftly undertook the process of disassembling and packing the assets, ensuring their safe transfer as per the instructions received.

On 14 September, the RSO BARMM employees rendered assistance to the Administrator by facilitating his swab test in BARMM. This was a mandatory requirement for the forthcoming inauguration of the Bangsamoro Parliament, scheduled for 15 September 2022. The RSO's dedication to supporting the Administrator's participation in this significant event exemplifies their commitment to seamless.

On 9 November 2022, it is important to acknowledge that all RSO Contract of Service personnel had their contracts terminated due to budget limitations. This regrettable decision was made in light of the financial constraints faced by the Authority, compelling prudent measures to optimize resource allocation and sustain essential operations. Furthermore, due to the prevailing financial constraints, the regular personnel, Mr. Ladjamurah and Mr. Talib, were recalled to the Main Office in Davao.

Throughout the entire period leading up to 13 November 2022, the employees of RSO-BARMM consistently reported to the office, to receive instructions from higher authorities such as the Administrator, Deputy Administrator, Department Managers, and/or Division Chiefs. This meticulous practice ensured compliance, effective follow-up, and seamless facilitation of tasks as required, embodying the unwavering commitment to professionalism and operational efficiency that resonated within the esteemed halls of RSO-BARMM.

FINANCIAL HIGHLIGHTS

SPDA BUDGETARY PROPOSAL FOR FY-2023 was submitted to the Department of Budget and Management (DBM) for deliberation and the recommended appropriated budget ceiling for the Authority for FY-2023 as communicated is ₱74.010 million. The Congress Committee on Appropriation and Senate Committee on Finance approved SPDA's budget of ₱74.010 million after the budget hearings conducted.

The approved regular budgetary appropriation for FY-2022 is ₱76.0 million. As of December 31, 2022, the total budgetary subsidy release from the National Government amounted to ₱ 86.0 million. These consist of the first to fourth quarter allotments only for the regular budget for Current Operating Expenses amounting to ₱76.0 million and the balance from the FY-2021 subsidy release for SPDA Projects amounting to ₱ 10.0 million which was released in the first semester of FY-2022.

Revenues and income generated for FY-2022 amounts to a total of Php 3,691,656.06 consisting of Php 2,707,153.87 from the rental and income generated of SPDA Koronadal Business Center and Php 984,502.19 from the sales income of SPDA Vitali Fish Pond Project.

Current Assets drastically reduced in CY-2022 due to the substantial reduction in cash account as the Covid-19 restrictions were lifted abd the Authority started implementation of the construction of its two (2) major projects, the SPDA Veterans, Zamboanga City Property into a Business Center and the SPDA Poultry Project in Sulop Davao del Sur. Property, plant and equipment account increased in CY-2022 due to acquisition of the poultry property in Sulop, Davao del Sur and the new office SPDA Manila Liaison Office. Increase in construction in progress is attributed to the on-going construction of the aforementioned two (2) projects and the SPDA Main Office in Catalunan Pequeño, Davao City. Increase in current liabilities is due to te payables to other government agencies like GSIS, Philhealth, BIR and Pag-ibig to be remitted the following month of January 2023.

The subsidy support to the Authority increased slightly in CY-2022 compared to CY-2021. Income and revenue generated in CY-2022 were derived from the operation of the SPDA Koronadal Business Center and the sales of the aqua products from the SPDA Vitali Fishpond Project. With the approval of the Compensation Position and Classification System (CPCS) for GOCCs in February 2022, SPDA's Personal Services Expenses increased by 17.205% compared to CY-2021 after three (3) years of no increase compared to the Salary Standardization Law (SSL) implementation of the National Agencies. SPDA however managed to reduced some of its MOOE in CY-2022 due to the reduction in office rental expenses as SPDA transferred to its newly constructed building in August 2022.
