# **REPORT OF ACCOMPLISHMENTS FIRST SEMESTER FY 2023**

# **OPERATIONAL HIGHLIGHTS**

SPDA VITALI FISHPOND PROJECT Vitali, Zamboanga City Region IX



For the First Semester of CY 2023, the management has decided to temporarily stop the operations of the Vitali Fishpond Estate for the conduct of re-assessment and evaluation of project management concerns in the area.



 During the visit of Zamboanga City Mayor John M. Dalipe and RDC IX Chairperson and SPDA Ex-Officio Board Member in the SPDA Main Office, Davao City last May 19, 2023, he promised to look for investors in Vitali for a joint-venture or lease agreement to operationalize the project.

#### SPDA KORONADAL BUSINESS CENTER Koronadal City SOCSKSARGEN



For the First Quarter of CY2023, the operation of the project generated a total gross revenue of **₱341,993.61** covering the period of January to March. The revenue was coming from Rent Income (Function Hall, Social Hall, and Commercial Space) in the amount of **₱312,166.61** and Sales Income (Hotel and Canteen) in the amount of **₱29,827.00**. The project is just recovering from the effects of the COVID-19 Pandemic.

#### SPDA POULTRY PROJECT Brgy. Labon, Sulop Davao del Sur



For the **First Semester of CY 2023**, the project focuses on the Supply, Installation, and Commissioning of Electro-Mechanical Equipment with Complete Controls and Accessories, as well as the installation of Ceiling. This latter scope of work was additionally required by San Miguel Foods, Inc. (SMFI) due to some modifications of the original structural design and was already incorporated on the ongoing contract. Equipment for the ventilation system, feeding line and feed hopper main filling system, curtain and heating system were initially delivered on the project site last **June 2023**.

Payment for the 80% portion of the contracted amount for the Electro-Mechanical component of the project was requested by the Contractor and paid by the office on **May 16, 2023**. Two other components of the project were earlier completed: the construction of the poultry house building and water supply system. The supply of two (2)-units 100KVA Diesel Generating Set are also in place. Broiler chicken production is targeted to start on the Fourth Quarter of CY 2023.



 SPDA Administrator Salapuddin met with Land Bank of the Philippines (LBP) Mindanao Lending Group headed by Senior Vice President Charlotte I. Corde, and Mindanao Lending Group head, Vice President Jose Enedicto G. Faune last January 11, 2023 for an exploratory meeting which was focused on possible financing and business partnership for the various projects of the Authority in Mindanao specifically the SPDA Poultry Project in Sulop held at LBP's Corporate Center along Palm Drive, Bajada, Davao City.

## SPDA VETERANS AVENUE PROPERTY PROPOSED DEVELOPMENT Veterans Avenue, Zamboanga City



On **January 31, 2023**, the Contractor submitted its **third progress billing**, representing its **15.65%** work accomplishment. This was already being checked and verified by the Assigned Project Engineer and Chief of Project Evaluation Division. Its actual physical accomplishments focused more on the tile work, ceiling, electrical and plumbing works. Payment for the said billing was made on **February 28, 2023**.

As of **June 2023**, the work accomplishments of the said project were already close to the final phase of its construction. The Contractor is currently doing the Glass works and Architectural design.

Negotiations with the prospective renters of the SPDA Veterans Office Building are also ongoing. To date, Rabzkhiel Drug Testing Laboratory, Al-Amanah Islamic Investment Bank, and TGP driving School have submitted letters of intent indicating their interest in leasing/renting one of its office spaces. SPDA Region IX Satellite Office shall also be housed in this Business Center.

SPDA WAO AND AMAI MANABILANG, LANAO DEL SUR, BARMM PROPERTY Proposed for Development into an Agro-industrial Area Lanao Del Sur



- On January 19, 2023, the SPDA Team, led by Administrator Abdulghani 'Gerry' Ajul Salapuddin, together with the Asia Pacific Precision Agriculture Group (ASPAC AG) Team, also led by their President and Chief Executive Officer Wilson T. de Vera braved the enormous challenges posed by the terrain ascending towards the ongoing project for an ocular inspection at Barangay Sumugot in the Municipality of Amai Manabilang, Lanao del Sur. The said location was also part of the area assigned to them by the Authority.
- In relation to the ongoing project of ASPAC AG, Authority made its First billing on April 17, 2023, and was requested to be validated on the ground, which was also confirmed by them without objection. The total initial area used by locator is already 34.70 hectares, situated in Brgy. Bandara Ingud, Amai-Manabilang, Lanao del Sur. Payment for the billing was received by the office on May 09, 2023, in the amount of ₱ 414,400.00.



 Officials of the KENNEMER Foods International had a courtesy visit and meeting with the SPDA Executive Committee led by Administrator Salapuddin last January 12, 2023 to discussed the possibility of a creation of Mindanao Special economic Zone (MINSEZ) with the SPDA Wao- Amai Manabilang, Lanao del Sur Property held at the SPDA Conference Room, Davao City.



 Last February 22, 2022, SPDA Administrator Salapuddin had a meeting and briefing to BGen. Leodevic B. Guinid, Commander, 1BCT, 6<sup>th</sup> Infantry "Kampilan" Division, Philippine Army (PA) on the pressing issues and concern of the SPDA Wao-Amai Manabilang Property in Lanao del Sur at SPDA Main Office, Davao City.



 SPDA Adminsitrator Salapuddin with SPDA Officials and ASPAC AG Vice President for Mindanao Edward 'Boy' dela Fuente had a coordination meeting with the Office of the President Adviser on Peace, Reconciliation and Unity (OPAPRU) Secretary Isidro L. Purisima and Director Jana Jill L. Gallardo last May 8, 2023 concerning the SPDA Wao-Amai Manabilang Property, Lanao del Sur current issues and concerns held at the OPAPRU Conference Room, 5/F Agustin I Building, F. Ortigas Jr. Road, Ortigas Center, Pasig City.



For a more efficient coordination and partnership with the different stakeholders, the Authority signed a Tripartite Memorandum of Agreement on June 21, 2023, with the Local Government Unit of the Municipality of Amai-Manabilang (formerly Bumbaran) and Western Mindanao Command, Armed Forces of the Philippines, at the Sangguniang Bayan Building, Amai-Manabilang, Lanao del Sur. This significant event shows the commitment and dedication of both parties to ensure the full implementation of the SPDA's AIDP activities in the Municipality of Amai Manabilang.

### SPDA PIÑA FIBER PRODUCTION PROJECT Manolo Fortich, Bukidnon Province (Proposed Project Site)

For the First Semester of CY 2023, the following are the actual activities conducted relative to the said project:

- To gather pertinent data essential in the drafting of the Memorandum of Agreement (MOA) between the SPDA and DEARBC, the Project Focal Person conducted a revalidation of data with the concerned officers of the DEL Monte Employees Agrarian Reform Beneficiary Cooperative (DEARBC).
- On June 07, 2023, the SPDA Team had a meeting/presentation of the proposed project to the Board of Directors and other Officers of DEARBC to get the consensus of the said officials.

To date, the project is still in the pre-implementation phase, where coordination meetings, procurement, and signing of MOA are scheduled accordingly. Piña Fiber Production is targeted to start in the Last Quarter of CY 2023.



 SPDA Administrator Salapuddin made a courtesy call visit to the Philippine Fiber Industry Development Authority (PhilFIDA) Executive Director Annray Villota Rivera to discuss the prospect of working as partners and to promote the fiber industry last March 17, 2023 at the Office of the Exceutive Director, Department of Agriculture Compound, Elliptical Road, Diliman, Quezon City.



 Philippine Fiber Industry Development Authority (PhilFIDA) Regional Office IX & BARMM Officer-In-Charge Zabdiel L. Lacarias visited and exchanged views and updates on the fiber industry in the country with SPDA Administrator Salapuddin last April 3, 2023 at the SPDA Conference Room, Davao City. The Authority has mapping out its multi-million fiber-related projects for CY 2023 at the Municipality of Manolo Fortich in Bukidnon, and at the Municipalities of Wao and Amai Manabilang in the Province of Lanao del Sur.


#### SPDA Marawi Property, Lanao del Sur

# **FINANCIAL HIGHLIGHTS**

- The approved regular budgetary appropriation for FY-2023 is ₱74.010 Million broken down into: General Administration and Support which amounts to ₱48.582 Million; the SPDA Piña Fiber Production Project approved budgetary requirement which amounts to ₱12.494 Million and the SPDA Abaca Production Project approved budgetary requirement of ₱12.934 Million. As of March 31, 2023, the total subsidy release from the National Government amounted to ₱12,146,000.00 which covers only for the Personnel Services for the first quarter allotment.
- Revenues and other income generated as of March 31, 2023 from the SPDA Koronadal Business Center is still on-going on the consolidation of its financial income statements. As of March 31, 2023, the Authority's financial performance consists of the following: Personnel Services Expenses amounts to ₱10,600,901.91; the MOOE Expenses amounts to ₱2,633,903.38 and the Total Net Surplus amounts to ₱1,369,364.60. Other projects are still under various pre-operating stages (construction phase and validation of market and firming up of business partnership) and are expected to contribute to corporate revenues either at the end of the last quarter of CY-2023 or the first quarter of CY- 2024.
