**“RESOLUTION DECLARING A SECOND (2nd) FAILURE OF BIDDING  
FOR THE PROCUREMENT OF THE THREE (3) UNITS BRAND NEW  
VEHICLES AND RECOMMENDING RESORT TO NEGOTIATED  
PROCUREMENT UNDER SECTION 53.1 (TWO FAILED BIDDINGS)”**

Held on February 26, 2020 (Wednesday)  
at the SPDA Conference Room

**WHEREAS**, the Southern Philippine Development Authority (SPDA) intends to procure three (3) Units of Brand New Vehicles, with an approved budget of the contract (ABC) of **FIVE MILLION AND ONE HUNDRED THOUSAND PESOS (Php5,100,000.00)**;

**WHEREAS**, the Bids and Awards Committee (BAC) declared a first failed bidding under BAC Resolution No. 2020-01-04 dated 09 January 2020;

**WHEREAS**, on 11 January 2020, the Bids and Awards Committee (BAC) posted continuously for eighteen (18) calendar days the **Invitation to Bid (ITB)** for the supply of three (3) Brand New Vehicles in the Philippine Government Electronic Procurement System (PhilGEPS) and SPDA website (www.spda.gov.ph) in accordance with Section 21.2 of the IRR of RA 9184;

**WHEREAS**, on 24 February 2020; 5:00 p.m., the deadline for the submission and receipt of bids, the Committee did not receive bids from any person or company;

**WHEREAS**, Section 35.1.a provides that the BAC shall declare a failure of bidding when no bids are received;

**NOW THEREFORE**, We, the Members of the SPDA-Bids and Awards Committee, unanimously resolve to the following:

1. Declare a **SECOND FAILURE OF BIDDING** for the procurement of three (3) Units of Brand New Vehicles pursuant to Section 35.1.a of the IRR of RA 9184;
2. Recommend to the Head of the Procuring Entity (HOPE) of the Southern Philippines Development Authority to resort to Negotiated Procurement under Section 53.1 (Two Failed Biddings) of the IRR of RA 9184.

This resolution shall take effect immediately.
