## ***Invitation to Bid***

### **PROCUREMENT OF THREE (3) UNITS BRAND NEW VEHICLES SPDA BR No. 2019-34**

1. The *Southern Philippines Development Authority (SPDA)*, through the *Corporate Operating Budget 2019* intends to apply the sum of Five Million and One Hundred Thousand Pesos (Php5,100,000.00) being the Approved Budget for the Contract (ABC) to payment under the contract of Procurement of Three (3) units brand new vehicles. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
2. The *SPDA* now invites bids for three (3) units brand new vehicles: One (1) unit Passenger Van 4x2; One (1) unit Pick-up 4x4; and One (1) unit MPV 4x2. Delivery of the Goods is required ***within fifteen (15) calendar days from receipt of Notice to Proceed***. Bidders should have completed, ***within one (1) year*** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
  - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from SPDA and inspect the Bidding Documents at the address given below during ***8:00 A.M. to 5:00 P.M. from Monday to Friday***.
5. A complete set of Bidding Documents may be purchased/acquired by interested Bidders on February 5 to 24, 2020 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos (P10,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of SPDA, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *SPDA* will hold a Pre-Bid Conference on **February 13, 2020; 9:00 a.m.** at *SPDA Conference Room*, which shall be **open only to all interested parties who have purchased the Bidding Documents.**
7. Bids must be duly received by the BAC Secretariat at the address below on or before **February 24, 2020; 5:00 p.m.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18.**

Bid opening shall be on **February 25, 2020; 10:00 a.m.** at *SPDA Conference Room*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. **Late bids shall not be accepted.**

8. The *SPDA* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
