WHEREAS, on May 03,2023, , the Bids and Awards Committee had declared the FIRST AUCTION as FAILED due to NO BIDS received during the opening of bids at at SPDA Main Office, Km. 12, Davao-Bukidnon Road, Catalunan Pequeno, Davao City.

WHEREAS, on May 04,2023, , the Bids and Awards Committee posted a second invitation to bid for the DISPOSAL OF SPDA PROPERTY THROUGH AUCTION SALES AT BARANGAY CATALUNAN PEQUENO, DAVAO CITY on May 04,2023, after the failure of the FIRST AUCTION as per BAC Resolution No. 2023-05-01.

WHEREAS, the Southern Philippines Development Authority (SPDA) Asset Management and Disposal Committee conducted an opening of bids on May 11,2023 (10:30am) at the SPDA Conference Room, SPDA Main Office, Km. 12, Davao-Bukidnon Road, Catalunan Pequeno, Davao City.

WHEREAS, the SPDA Asset Management and Disposal Committee confirmed that there was no bidder who bought the bid documents.

WHEREAS, upon opening of bids, it was declared "FAILED", due to no bids submitted to SPDA Asset Management and Disposal Committee or received by them.
